AnaeCo entered into a loan agreement with Monadelphous Group Limited to access funding ahead of receipt of the R&D Tax Incentive Refund for the 2014 financial year. During the quarter, AnaeCo borrowed \$2.549 million.

On 7 October 2014 AnaeCo received a tax refund of \$4.590 million for the 2014 income tax year based on eligible expenditure incurred under the R&D Tax Incentive scheme, and the total amount borrowed was repaid at that time.


